### **General Description of the Project (Riverbend)**

- Stabilizing the riverbed and banks in a location where there is a lot of foot traffic and public visibility. Improve safety for park users.
- Protect the sanitary sewer line crossing from possible damage during flood conditions.

#### **Bidding Considerations (Riverbend)**

- Expected flows in the river, November to April.
- Contract allows for approximately 6 months to complete the contract. Why is that?

- Contractor will have to provide a detailed schedule of work and will have to notify the Village 7 days prior to any mobilization/demobilization dates.
- 404 Permit has been obtained from the USACE.
- Contractor access & staging considerations. Importance of managing the curious public during construction. Limits on time duration of non-work activities, and public safety.
- Spec for large rock includes two different size/shape requirements.
- Expectations for the finished project look: aesthetically clean, stacked rock does not create a safety hazard, visually pleasing.
- Water management bid item.
- SWPPP implementation and permit only required if disturbance area exceeds minimum threshold.

### **Roles and Responsibilities (VOR + Riverbend)**

- Roles of the Contractor, the Owner, and the Engineer, Key Contacts.
- Surveying The Contractor will subcontract for layout staking and as-built documentation.
- Contractor required to contact NM One Call.
- Testing lab required for concrete materials verification.
