ADDENDUM #5

Purpose: This addendum is to correct the percentage allowed for Resident Contractors and Resident Veteran Contractors according to Section 13-1-21 NMSA 1978 and add additional language.

Current Language:

- 5.03 This Contract includes two (2) preferences for the award of the Bid: (1) New Mexico Resident Contractor Preference and (2) Resident Veteran Preference Certification.
 - A. To receive a Resident Contractor preference pursuant to Section 13-4-2 NMSA 1978 or a Resident Veteran Contractor preference pursuant to Section 13-1-21 NMSA 1978, a Bidder shall submit with its Bid a copy of a valid Resident Contractor Certification or Resident Veteran Contract Certificate issue by the Taxation and Revenue Department. In addition, if the Bidder is seeking the Resident Veteran Contractor preference, the Bidder shall submit with this Bid the Resident Veterans Preference Certification form.
 - B. For the purpose of awarding, the following shall apply:
 - 1. A Bid submitted by a Resident Contractor shall be deemed to be five percent (5%) lower than the Bid actually submitted.
 - 2. A Bid submitted by a Resident Veteran/Contractor with annual revenue of up to Three Million Dollars (\$3,000,000) in the preceding tax year shall be deemed to be ten percent (10%) lower than the Bid actually submitted.

Change to:

5.03 This Contract includes two (2) preferences for the award of the Bid: (1) New Mexico resident business or Native American resident business preference and (2) New Mexico resident veteran business or Native American resident veteran business preference according to Section 13-1-21 NMSA 1978.

- A. To receive a resident business or Native American resident business preference pursuant to Section 13-1-21 NMSA 1978 or a resident veteran business or Native American resident veteran business preference pursuant to Section 13-1-21 NMSA 1978, a Bidder shall submit with its Bid a copy of a valid resident business or Native American resident business certification, or resident veteran business or Native American resident veteran business certificate issued by the Taxation and Revenue Department.
- B. For the purpose of awarding, the following shall apply:
 - 1. A Bid submitted by a resident business or Native American resident business shall be deemed to be eight percent (8%) lower than the Bid actually submitted.
 - 2. A Bid submitted by a resident veteran business or a Native American resident veteran business with annual revenue of up to Six Million Dollars (\$6,000,000) in the preceding tax year shall be deemed to be ten percent (10%) lower than the Bid actually submitted.
